Comes now the State of Tennessee, by and through the District Attorney General for the Sixth Judicial District, in response to the Defendant's Motion to Compel Disclosure of Offers to Co-Defendants and says that Vanessa Coleman was offered a sentence of life with the possibility of parole on her plea of guilty. If she accepted, she was expected to testify truthfully if called in any subsequent hearing pertaining to the murders of Chris Newsom and Channon Christian. Further details concerning which counts would be involved were not discussed before the offer was rejected. The offer was conveyed orally and rejected orally. The State has not made offers to any other defendant in this matter.
